Professor of Accounting and Co-Director of the FinWork Futures Research Centre at King's Business School, King's College, UK Crawford Spence is Professor of Accounting with broader interests in economic sociology. He has published extensively across a range of accounting, organisational and sociology journals. He sits on the editorial boards of Accounting, Organizations and Society, the Accounting, Auditing and Accountability Journal and Contemporary Accounting Research. His research has explored corporate accountability, corporate tax, professional elites and expertise in financial markets. He joined King's in 2017 and has held visiting or permanent appointments in Canada, Japan, Norway, France and Spain.

Along with Alex Preda and Rita Samiolo, Crawford co-directs the FinWork Futures Research Centre at King's, which explores how technological innovation is disrupting financial professions and financial expertise.

Crawford's work has been funded recently by the British Academy, UKRI and he currently holds a Leverhulme Fellowship (2020-2022) to explore 'Audit in the Age of Machines'.

Dr. Tan is an Associate Professor of Information Systems at the University of New South Wales (UNSW) Business School. His research interests include Digital Platforms, Information Systems for Good, Sports Digitalization, E-Commerce and Enterprise Systems. He actively examines these interests in the context of Digital Transformation for business and social change. His research work has been published in various academic and practitioner journals such as Information Systems Journal, Information and Management, MISQ Executive, Communications of the AIS, International Journal of Information Management and Australasian Journal of Information Systems (Google Scholar). Dr Tan is presently serving as Associate Editor of Information Systems Journal (ABDC A\*, Basket of 8) and Information and Management (ABDC A\*). Dr Tan is presently serving as the Association of Information Systems Region 3 (Asia-Pacific) Diversity and Inclusion Taskforce representative. Dr Tan is presently serving on the SAP Academic Alliance Board (Asia-Pacific and Japan). Dr Tan is the founder of UNOVA, a transdisciplinary research and development lab at UNSW.





**Professor Tim Lemper** Kelley School of Business, Indiana University, USA Professor Lemper teaches in Kelley's undergraduate, full-time MBA, and Kelley Direct MBA programs, as well as Kelley's partner MBA program at Sungkyunkwan University (SKK) in Seoul, South Korea. He has also taught courses for the Media School, the Cybersecurity Risk Management program, and the Wells Scholars program at IU.

Prof. Lemper serves as Kelley's Faculty Liaison for Undergraduate Student Engagement, having previously served nearly a decade as chairperson of Kelley's Academic Fairness Committee. He is also Director of the Legal Advising Forum at the Johnson Center for Entrepreneurship & Innovation, and is affiliated with the Center for Intellectual Property Research at IU's Maurer School of Law.

Prof. Lemper's teaching and research focus on the law of unfair competition, intellectual property law, marketing law, First Amendment and constitutional Law, and media law. In 2012, Congress passed and President Obama signed Public Law 112–190 to amend the federal trademark dilution statute in direct response to Prof. Lemper's research. He is a co-author of a business law textbook.

Prof. Lemper has a Juris Doctorate from Harvard Law School, a Master of Science degree in Public Administration & Public Policy from the London School of Economics & Political Science, and Bachelor degrees in Political Science, History, and English from Indiana University, where he also completed the Liberal Arts & Management Program. He is a former Harry S. Truman Scholar and Herman B Wells Scholar, and currently serves as chairperson of IU's Nominating Committee for the Rhodes, Marshall, Mitchell, and Churchill Scholarships.

Professor Lemper has a broad range of professional experience, including practicing as an intellectual property and First Amendment litigator, serving as a staff assistant to U.S. Senator Richard Lugar, working as a consultant to the Air Staff for the United States Air Force at the Pentagon, interning in the British House of Commons, and participating in several businesses and non-profit organizations.
